Our designers build and maintain design patterns and components with accessibility and consistency in mind. Our developers build accessibility into the web components they create as building blocks for product development. Accessibility testing starts in our dedicated UX department and is tested well into the development phase to make sure results are on par with expectations. Expectations are tested using software that simulates common user disabilities such as color-blindness. Our QA staff includes a user who is color blind, giving us fast, accurate feedback on something that might cause an accessibility problem.
